### District Governor 2012-2013, RI District 3140

Wednesday, March 6, 2013 was a special day for the Rotary Club of Bombay Mid-Town, when our District Governor, Dr. Balkrishna Inamdar made his Official Club Visit (OCV).

Dr. Inamdar is a multifaceted personality who has excelled in every spheres of life he ventured, in medical

profession, in sports and also in Rotary. He is a national scholar and stood 9th in the medical merit list in 1973. He is an M.D. in Gynecology-Obstetrics and also holds a Diploma in Pelvic Surgery. Dr. Inamdar is a natural leader. He was the vice-president of IMA, Maharashtra State in 2007-08 and President of IMA. Mumbai West in 2010-11.


Dr. Inamdar joined Rotary Club of Mumbai West Coast as its charter member in 1996, and became its President in 1999-2000. He has addressed more than 500 club meetings

and other groups on Rotary and non-Rotary subjects. Our club also had the opportunity to listen to such a talented personality speak at our Club meeting on the day of his OCV.

When Dr. Inamdar spoke, we realised that the words came straight from his heart. He broached the important areas of concern for us:

The first, was on the projects that are being undertaken. He mentioned that it is important to undertake an audit of all the projects, including the vocational projects. He mentioned that it is more important to assess what has to be done, than what we have done. It is not important where we stand at the present moment; but to see where we are going, what direction we are taking. Only then we shall fulfill





taking cognisance of the same. There are many instances where Rotary is not even mentioned in the articles on the subject of polio eradication.

Lastly, he mentioned that despite a lot of good work being done, people feel that we are not doing anything great apart from polio eradication. There are other issues of the similar magnitude being tackled by Rotary. That's why the concept of 'Service 12' was evolved. It is a concept where many clubs have come together for a few focused areas: mainly 12 big projects. These include

10,000 career guidances, 8,000 to 10,000 cataract surgeries, micro credit to women, scholarships to worthy students, etc.

Dr. Inamdar concluded his address by stressing that we should contribute to the Rotary Foundation. He mentioned that while Rotary International is the brains behind what we do, Rotary Foundation is the heart. And hence, he urged us to practice Rotary with Heart.

### Insights into the Art of Jewellery

One of our very own former Rotarians', Bijal Doshi, gave us a very interesting and informative presentation on the various aspects of jewellery. Bijal has been in the jewellery business for many years, and designed jewellery for celebrities such as Michael Jackson. She won the first prize for the best designs in the Inner Wheel South Asia Rally 2008. She is multi-talented, because not only is she a successful business woman, but she also runs a yoga school, and has been teaching yoga for about eight years.



She gave us a brief outline of the process required in making a piece of jewellery, and showed us some examples of incomplete pieces at various stages of production. She gave us ideas on how to choose a jeweller, and what to be wary of — all that glitters is not gold! We learned about the many settings one has to choose from when designing a piece of jewellery. Her advice for choosing a jeweller was basically that one should choose someone competitively priced, and with designs we like.

In order to get a good price when choosing a solitaire, her tip was that we should ask for the Rappaport Diamond Report. This report comes every Friday, and gives diamonds rates in US dollars. In the question and answer period, someone asked how you can

identify fake diamonds. Her answer was that fake diamonds weighed less, and also have a fluorescence or purple haze around them. To avoid being cheated, she recommended getting a certificate, and perhaps getting a laser inscription on the diamond.

She commented briefly on the state of the luxury industry. According to her, branding is very important as well as the packaging and follow-up with clients. When it comes to buying a piece of jewellery people differ in their approach. Some

people buy it more as an investment, and others to complement their image. People can match jewellery to their clothes, or the other way around. A term she used was 'hero piece', which means a main piece of jewellery that is the focal point of your ensemble. When you wear a 'hero piece', other jewellery items should be kept to a minimum.

The meeting was well attended, and several Inner Wheel members were present.





### The Lighter side of Medicine

With healthcare being the stressful and serious environment it is, sometimes we can lose the lighter side of medicine. The Rotarians had an enlightening and humorous afternoon when they listened to the medical stalwarts of our Club.

The speakers were none other than Dr. Shirish Sheth, Dr. Anil Tibrewala and Dr. Ghanshyam Kasbekar. While narrating the lighter side of medicine, they communicated some very important message to the audience. But before we get into what they advised, let us take a quick look at their professional achievements:

Prof. Dr. Shirish Sheth has had a distinguished career as a gynaecologic surgeon. He was the Hon. Professor, Obstetrician and Gynaecologist, King Edward Memorial Hospital and Seth G. S. Medical College, till December 1994. Presently, he is associated with Breach Candy Hospital, Sir Hurkisondas Hospital and Saifee Hospital in Mumbai as a Consultant Gynaecologist. From 2000 to 2003, he was the President of International Federation of Gynecology and Obstetrics. Moreover, Dr. Sheth was the District Governor, Rotary International in 1983-84 and has contributed a lot in social service. He has conducted more than 40 Laparoscopic Sterilisation Camps and has performed more than 10,000 Laparoscopic Sterilisations as community service in rural India. He is the recipient of Rotary International Meritorious Service Award, 1986, Distinguished Service Award of The Rotary Foundation, 1995, the highest Rotary Award 'Service Above Self Award, 2002' and District Vocational Excellence Award, 2000 and 2010 at the District Conference 3140. And he was the President of our club in 1976-77.

His honest, straightforward and humane approach coupled with his vast experience and technical expertise, makes Dr. Anil Tibrewala one of the most sought after Cosmetic and Plastic Surgeons in India. Dr. Tibrewala is an M.S. in General Surgery and an M.Ch. in Plastic Surgery. He also pursued his primary interest, and did his Fellowship in Cosmetic Surgery from a premier institute in Paris, France. For nearly 15 years, Dr. Tibrewala has been a regular member of the Free Plastic Surgery Camps for the needy and poor in the interiors of India. Dr. Tibrewala has taken training in Vocal Hindustani classical music, and also has deep passion for all things culinary.

Dr. Ghanshyam (Arvind) P. Kasbekar, is a Pediatrician par excellence. He is an MBBS, MD and DCH. He has been a PostGraduate and UnderGraduate teacher at the Grant Medical College and Sir J.J. Hospital. He is a Senior Consultant Pediatrician at Bhatia, Saifee and Motiben Dalvi Hospitals in Mumbai and the Head of the Teaching Faculty at Bhatia Hospital. He also teaches at Sir J.J. hospital. Dr. Kasbekar has been an active Rotarian in our club since 1995, and he enjoys music, socialising and teaching medical students.

The above speakers shared few interesting anecdotes arising from their professional life.

Dr. Tibrewala commenced with explaining what Plastic Surgery was, and went on to explain the manner in which it is so misunderstood and misused. Plastic surgery is a medical specialty concerned with the correction or restoration of form and function. Though cosmetic



surgery is the best-known kind of plastic surgery, most plastic surgeries are not cosmetic plastic surgeries. Cosmetic plastic surgery involves techniques intended for the 'enhancement' of appearance through surgical and medical techniques, and is specifically concerned with maintaining normal appearance, restoring it, or enhancing it beyond the average level toward some aesthetic ideal. Dr. Tibrewala, aided with some visuals and a few anecdotes, advised the audience to be vary of the newspaper advertisements for quick fixes. It is always advisable to consult a professional doctor for any kind of cosmetic plastic surgery.

Dr. Ghanshyam Kasbekar also had the audience in splits with his anecdotes about the mothers who came for his consulation for their children. Dr. Kasbekar has mastered the three most common complaints — maro babo jamto nathi, vajan nathi vadhtu, lambo nathi thato. But most importantly, Dr. Kasbekar mentioned, that the joy and affection that he gets from the parents whose children



have been treated by him cannot be compared to any amount of money.

Dr. Shirish Sheth narrated some very laughable incidences from his experience. While all his anecdotes were hilarious, Dr. Sheth mentioned that there was a lot innocence and a lot of ignorance which many time arose because of the misuse of language.

In summary, all three doctors mentioned that patients should leave it to a professional doctor to perform his profession and refrain from instructing him what to do.



### The Inner Wheel: Supporting a Cause

Towards the end of February 2013, we took up a project which was on our minds since a long time, but kept getting held up due to some reason or another.

Polio is on the verge of eradication, the world over. India too is close to ending the disease for good, provided we continue to support the efforts of active surveillance of the disease. It is also necessary to look at other health interventions, including measles vaccinations and distribution of deworming tablets and bed nets.

In the last three years hardly any polio case is registered. However, the routine polio doses have to be administered to children. February 24 was the day when Asha Bhatia and myself went to the polio centre at Khetwadi. Around that area, there are 22 polio centres, where 2,400 children are given polio drops during that week. Rotary Centre supplied to us banners, caps and plastic balls for children. Banners were put up at strategic places. Snacks and cold drinks were supplied by us for the 66 volunteers.

Over a period of time we have learnt that spreading awareness is not only the job of a handful of officials, but up to each one of us. Inner Wheel ladies have been supporting this cause since many years and will continue to work with Rotarians on this. 

### Building a future for Mumbai's street children


the repairs, repainting, and supply refurbishing educational aids to the various centres of "Salaam Baalak Trust" (SBT) have been completed. We were very sorry to learn that Trustee Mrs. Dorothy Wagle was relinquishing her responsibilities for health reasons. Rtn. Zarin Gupta has taken over the reigns.

A major pioneering challenge is the 'Career Courses' which we have been offering to the street children between 18 and 23 years of age — in Hospitality, Readymade Garments, House keeping and similar trades. There is a reluctance to tie themselves

down to six months of regular training sessions. The opportunity for being able to earn a steady income is still not able to overcome ingrained desires for personal 'freedom' and 'live-by-the-day' philosophy. Both SBT and our committee are making all-out efforts to try and gradually overcome these barriers through counselling, interactive sessions, etc. A valuable qualitative study was recently completed by the Tata Institute of Social Sciences (TISS) and presented to us.

This presentation was repeated at a meeting convened by SBT at the YMCA, Mumbai Central, on January 24, which was attended by 45 NGOs from all over Mumbai. For the first time, all these NGOs agreed to pool in their combined expertise and knowledge for serving the cause of street children. They also witnessed results of the TISS study and made valuable suggestions.





Mr Luc De May from Brussels, the 'God Father' of our project, paid his annual visit in February, and made a detailed inspection of the work carried out at the various centres. He was also present at a detailed Review Meeting held with SBT and Bombay Mid-Town Committee on February 8, 2013 at the CCI club. On this occasion, Tom Alexander, a research student from the UK commissioned by us, presented his findings about the impact made by our Global Grant project (Phase I) on the staff and children at the various centres, both qualitatively and quantitatively. Results clearly showed that the repairs. Extensions the facilities, as well

educational aids, have made a huge and positive impact on the morale of the staff. Capacity to serve more number of street children has been significantly increased — as also the ability to communicate/educate a greater number at a time, through large screen TV sets, video shows etc. The computerisation has enabled SBT to introduce excellent systems and exercise better controls on their operations.

Prospect of SBT acquiring additional premises soon is a good possibility and we are getting ready to plan the renovation and equipping of the places with Global Grant funds, as soon as the locations are finalised.

- → Active participation of Dr. Anil Tibrewala, Consultant Plastic Surgeon, as one of the operating surgeons.
- → Large monetary and incidental support from Rotarian Dr. B. N. Barwale, who has almost single-handedly taken it upon himself to ensure that the camp succeeds under even the most dire circumstances.

This year we were saddened to hear of the ill health of Dr. Gerhard Schlosser, who has generally served as the main coordinator and team leader for the last nine years. As a result of this, the cleft lip and palate team backed off from the trip. Their place, however, was taken by our very own Dr. Anil Tibrewala, who performed about 25 operations on his own, so as not to disappoint the poor needy patients who had travelled long distances to avail of this Free service.

All together, about 100 procedures were performed on over 85 patients. Until yesterday, all patients were reported to be doing well and recovering well.

The 10th Free Plastic Surgery camp was held in Jalna between February 23, 2013 and March 5, 2013. The camp was held at Jalna Mission Hospital with the co-operation of the following clubs:

- RC Hattingen, Germany
- RC Jalna
- RC Bombay Mid-Town.

This year, we were particularly fortunate to have the participation of the Rotary Foundation in the form of a matching grant, which was applied for along with five Rotary Clubs from Columbia. Every year, we are also fortunate to have the help of a team of German Volunteer Doctors, consisting of surgeons, anaesthetists, trained nurses, etc., who come entirely of their own free will, year after year, to do this charitable work. They come in two teams - one that looks after patients with cleft lip and palate, and the other that looks after patients with burns, scars and contractures. The team brings along surgical instruments required for the various operations, as well as anaesthesia drugs, antibiotics, pain killers, etc, required for the patients who are operated upon. In addition, they bring along with them soft toys for children who undergo an operation. These toys are collected as voluntary donations from the families in their hometown, where children are explained the need for them to make this contribution. Additional support for medications,

### You run a successful packaging business. Can you give us a little insight into what your company does?


a couple of years whilst simultaneously completing his law degree from the Government Law College, Mumbai. He is currently working with a leading law firm in Mumbai.
