Gift of Life

12 Little hearts were given a "Gift of Life" in March '22, through cardiac Pediatric procedures, thanks to a novel project by our club association with Centaur Pharmaceuticals P. Ltd., at the Sri Sathya Sai Sanjeevani Centre for Child Heart Care. The uniqueness of the facility is that it treats all patients on merit and there is no Billing counter, so the patients pay nothing - something unheard of in India. Everything is sponsored by large hearted Rotarians and other citizens like Mr. Sawant.

The facility at Navi Mumbai (one of 3 such in the country) is run by Sri Sathya Sai Health & Education Trust. The other two centres are in Raipur, Chhattisgarh and Palwal, Haryana near Delhi. The focus in all the 3 centres is on Pediatric Cardiac Care, addressing India's largest cause for Infant Mortality - Congenital Heart Disease, (CHD) which has emerged as the most common defect at birth in India with over 2,40,000 such children born every year.

Due to lack of timely detection, lack of access to quality health care and lack of affordability, this disease has become a major cause of child mortality in our Country. Many children due to late diagnosis or lack of access and affordability to health





care live a morbid life and sometimes even become inoperable.

This Trust is doing phenomenal work and in the last eight years, have conducted over 19,000 Pediatric cardiac surgeries and Pediatric Cardiac Cath interventions, for children coming from all states of India and 14 developing countries.

On 11th March, President Rtn. Burjor Nariman, Dr. Arvind Kasbekear and Rtn. Anil Ambo spent a full day at the Hospital at Navi Mumbai, Maharashra, doing due diligence and satisfying themselves that this is the place to tie up with. Rtn. Anil Kamath could not join in the visit, but is a big support to the project. Theteam came back thoroughly satisfied, including enjoying a simple saatvik meal at the hospital.

Thanks to Mr. Sawant's gracious contribution of 15 Lacs. under CSR by Centaur Pharmaceuticals P. Ltd., it was decided to go ahead and by 31st March, a new lease of life was given to 12 children with Congenital Heart Disease. While the actual cost of treatment at Sai Sanjeevani ranges from Rs 1 Lakh to 4 lakhs based on complexity of the case and ICU stay, average cost of treatment at Sai Sanjeevani is Rs 1.3 lakhs per child.

After the success of this project, our Team met Mr. Sawant, his daughter and officers to make a presentation of the work done. Mr. Sawant was very pleased and he immediately promised to associate with us in this and other projects over the next few years.

Gaining confidence from this experience, our Club is working on two more projects in this area

 Our Global Grant joint project with Queen City, for \$ 1,00,000 has been approved by RI. It should roll out any day soon. For this we are grateful to generous donations by Rtn. Kalpana Shrivastava, Rtn. Prakash Mody, Rtn.Asha Thacker Singh, Rtn. Aditi Choksi, Rtn. Rajendra Barwale, Rtn. Bimal Shroff, Rtn. Sucharita Hegde, Rtn. Ashwin Shah, Dr. Firoze Mirza & Rtn. Minal Jilla. In addition valuable guidance by Rtn. Ravi Harlalka is gratefully acknowledged.

2. Our above CSR project of approx. \$ 20,000 was done by the Club directly. Now we plan to route the next CSR project of apporx \$ 75,000 or higher through RI. By this detour, the advantage to you generous Rotarians, is that your contributions to this project will not only get you the satisfaction of participating in the project directly, but you will also get TRF credits. We are happy to announce that so far, Rtn. Rohit Patel, Rtn. Harshad Vora and Rtn. Mohan Shahani have made large contributions to this project being planned.



Where there is a Will... there's a way

Why one must write a Will

The origin of Wills in India is not known. While the Sanskrit writers have described documents like Partition, Gift, Purchase,

Debt etc., there is no express mention of Will in ancient scripts. In the olden days an orthodox Hindu would always have contemplated that his properties will naturally pass on to his children and nearest relatives. Text of **Narada** says "What exceeds the maintenance of the family may be given away".

However, **present day scenario** is different. The fights amongst family members, after the death of Head of family, are rampant. May it be "Ambani" family or "Birla" family, the legal disputes have grown. This has given rise to a need for testamentary disposition according to

one's own desire. The obvious need for making a "Will" are succession planning, avoidance of

disputes, pre-determination of disposal of wealth and protection of interest of non-earning or physically weak members of the family.

After the death of a person, his or her property devolves in two ways. By way of a Will which is called **'Testamentary'** succession and by respective laws of succession when no Will is made which is called **"Intestate"** succession. While Hindu Succession Act governs Hindus, Buddhists, Sikhs and Jains and the Indian.

A will is a personal declaration which takes effect after the death of the Testator. It is revocable during the life time, unlike a 'Gift' which in most cases is irrevocable. Any adult person in sound state of mind is competent to make a Will. A minor, or a corporate body or an insane or a lunatic or an insolvent person cannot make it.

The advantages of Will are many. It eliminates confusion on estate, it allows devolution of property in a personalized manner, it can provide more for a physically challenged relative or a widowed daughter or an invalid relative.

A will must be made in writing. The only exception is for Defense personnel like Soldiers, mariners and airmen, who can make an oral Will under certain circumstances. Two witnesses signing along with the Testator is a must and a medical certificate is desirable. Registration of a

Will is not compulsory u/s. 18 of Registration Act. However, it is always desirable to do so to avoid many disputes.

The law also provides for a **Probate** which is a certificate given by a competent Court about genuineness of a Will. While making a Probate Petition, declaration of witnesses and no objection from other legal heirs is a must.

The challenges to the Will, which are often seen in the Courts are on diverse grounds such as the person was not of sound mind; his signature was not genuine; he was unduly influenced; it was procured by fraud; the witnesses had not signed; or they were made up.

An interesting concept which is recently developed as per the Supreme Court judgement in the case of NGO "COMMON CAUSE" is of making a "LIVING WILL". Such Will is basically a document that spells out medical treatment a person would and would not want to be used to keep him/her alive as well as other decision such as pain management or Organ donation. You can address a number of possible end-of-life care decisions in your Living Will.

It is therefore advisable that your Will is drafted by a competent lawyer, it is registered, and the Executors appointed in the Will are trustworthy persons. So, don't leave anything to chance. You have earned your assets and MAKE your Will today only as death is certain on one day!

Speaker Rtn Rajeev Thakkar

On 13th April we had the privilege of having our very own Rtn Rajeev Thakkar speaking to us on "Making your Investments Termite Proof" at the President Hotel, Assembly Room.

He is the CEO of PPFAS MF. He gave examples of high profile wealthy individuals going bankrupt like Boris Becker, Mike Tyson and Michael Jackson. Even Mr Amitabh Bachchan was almost declared bankrupt. In most cases it was due to lavish lifestyles, heavy borrowing, lack of proper succession and financial planning. The biggest termites, according to Rajeev are taxes, inflation, they eat into your yearly savings and wealth. In India, we pay taxes at the rate of 40%, surcharges add to this. Wise way to invest in tax sheltered structures like PPF, NPS, MFs, Insurance Policies. Bond Funds offer tax protection to some extent. He advised members to put money to work by investing in REITs, Real estate, Sovereign Gold Bonds, Equity, 5 year deposits. Because of high costs of fuel, purchasing power comes down, businesses are not able to get raw materials, prices rise as the demand goes up but the supply decreases. However, this is not a permanent problem and he ended his talk jocularly saying that, spend some money by giving it to the Rotary!

The event was well attended by members and spouses.



Speaker Rtn Zeenat Ali

On 16th March our very own Rotarian, the charming and exuberant Ms Zeenat Ali spoke on "The Aspects of Hijab" at the President Hotel, Assembly Room.

As per Zeenat, "Islam has not introduced the hijab. In olden days, ladies of all the ancient civilizations used to wear a particular type of attire, according to their cultures. Their cloaks covered their bodies, however hijab was not a part of their clothing, it was not used as any fashion apparel. Ladies in those days were asked to

dress modestly and cover themselves to look decent. They could wear any decent dress belonging to their culture and wearing a hijab was not absolute. The wrong interpretation came over the years, where women of loose character could wear anything and good women would cover their heads".

"Presently it has become a raging debate, young minds are held hostages at what the clerics have to say. Why do we have moral policing? Why cannot girls make their own choice? The Constitution of India, gives that choice. Why are we silent on male oriented symbols of religion? The whole issue has taken a political hue.

In the judgement passed by the Supreme court to wear the prescribed uniforms, as uniforms in school need to be religion neutral, however, it was also directed by the court to investigate the unseen hand that started the controversy in Karnataka. Opposition to the hijab exists even in Muslim countries, 6 countries like Azerbaijan Tajikistan etc. do not allow hijabs even in government offices. She made an impassioned plea to women not to be ignorant, as it is the men (clerics) who chose to keep you ignorant".
